## BIOGRAPHY

Before starting his trial practice, Scott Barker served in the U.S. Air Force for 12 years—including four as a cadet at the U.S. Air Force Academy—with tours of duty in Southeast Asia and the Pentagon. In his 40-year legal career, he has tried nearly 80 cases and handled scores of evidentiary hearings, ranging from complex class action jury trials to pro bono proceedings for domestic violence survivors.

Scott has earned the respect of clients, judges, and lawyers wherever he has appeared in the United States, as reflected in his numerous professional accolades. Most prominently, he was selected as a Fellow of the American College of Trial Lawyers in 2001. In addition, he is a skilled leader of sophisticated practitioners. Scott served as the Chair of the Management Committee of the largest Denver-based law firm for six years before joining WTO in 2010 as a partner and member of the firm's Executive Committee.

Now, as Senior Counsel, Scott's passion is serving clients by helping the firm's lawyers to hone their trial presentations and appellate arguments. Given the depth and breadth of his trial experience, Scott is also an effective mediator and arbitrator. Finally, he is an avid student of the Constitution. Since 2018, Scott has authored three published books and several articles and op-eds about our founding document and its impact on current events.

- Defeated class certification for Nash Finch (now SpartanNash), a Fortune 500 food distribution company, in claims involving common law fraud, civil theft, and violations of the Colorado Consumer Protection Act stemming from complaints about a specific pricing program in various grocery stores. WTO then obtained summary judgment against the 55 named plaintiffs.
- Served as lead counsel to Amoco Production Co. in a major groundwater contamination case in southwestern Colorado and northwestern New Mexico. Plaintiffs alleged Amoco's gas production operations had contaminated domestic water supplies across an area the size of Rhode Island. The putative class action, if certified, would have produced exposure in the billions of dollars. Scott's team defeated class certification and successfully tried the named plaintiffs' cases to a jury.
- Obtained a defense verdict for ARCO/Thunder Basin Coal Company in an antitrust case involving real estate development incident to a client's coal mining operations in Campbell County, Wyoming.
- Served as lead trial counsel to Asarco, Inc., in a six-week class action jury trial in Denver District Court involving allegations of heavy metals contamination in the area surrounding Asarco's cadmium refinery.
- Represented Aspen Skiing Company as lead trial counsel for over a decade, handling more than 30 cases, including 10 defense verdicts.
- Represented AT&T as lead counsel in a complex telecommunications dispute in federal court in Colorado.

Allegations included false claims associated with a contract for management of the U.S. Department of Energy facility in Idaho Falls, ID. Following summary judgment, the remainder of the case settled favorably.
